ELECARD TRANSFORM FILTER PACK LICENSE AGREEMENT

3.4. You shall indemnify, hold harmless, and defend Elecard from and against any claims or lawsuits, including attorney's fees, that arise or result from your deployment and distribution of the Software as part of your own product;
